Junior League of Columbus (JLC) makes an impact in Central Ohio

The Junior League of Columbus donated over \$75,000 in financial support and 3,482 hours in volunteer time to grant programs, collaborative efforts and community projects in the 2021-2022 League year. Through direct outreach, the JLC impacts many lives in Central Ohio. What follows are highlights of the many ways the JLC is making a difference:



In 2020, the Junior League of Columbus narrowed down our focus to find a true need in the Columbus area where our members can make a big impact. The Junior League of Columbus' new project, Bridging the G.A.P. (Guide, Advocate, Provide.), supports youth aging out of foster care.

As a part of the Bridging the G.A.P. Initiative, the Project Guide team partnered with Franklin County Children Services to provide educational courses called Life Skills Classes to youth in foster care in Central Ohio. The classes occurred three times this year, once in the fall, winter and spring. Courses occurred every Tuesday evening during the seven week course and covered topics from housing and employment to interviewing skills and money management. Junior League members were given the opportunity to participate in the classes and share their professional and personal experiences in the specific topic areas. Youth were able to ask questions and learn from the members' mistakes and triumphs.

Another important part of Bridging the G.A.P. is advocating on behalf of our foster youth. Project Advocate focuses on educating members and the community about transitional-age foster youth. In May, during National Foster Care Month, Project Advocate does a social media campaign called "Fostering Change by Bridging the G.A.P." The social media campaign raises awareness for all of our foster youths' needs.

Project Provide is where the Junior League physically gives back to foster youth. In the 2019-2020 League year, we formed a partnership with Star House and have been supporting the youth living in Carol Stewart Village through providing them with household necessities to start their new life in their very own studio apartment. Additionally, this League year we partnered with Huckleberry House on their Holiday Drive and gave many holiday gifts to youth and kids in foster care. Lastly, we utilized our connections with Franklin County Children Services to provide 51 youth in foster care that are graduating high school with graduations gifts. Since the beginning of Bridging the G.A.P., the Junior League of Columbus has donated over \$13,000 back to foster youth.

Diversity, Equity, Inclusion, & Belonging Speaker Series

The Junior League of Columbus' Diversity, Equity, Inclusion and Belonging (DEIB) Committee worked tirelessly throughout the 2021-2022 League year to bring DEIB topics to the forefront. The Committee identified an opportunity to have a speaker series where they would bring in leaders within the Columbus community to educate JLC and community members about these important topics and work that is being done to advance DEIB. The Committee applied for a grant through the Small Leagues Big Impact affinity group through AJLI and were awarded \$100 for this initiative. The first event in the Speaker Series featured Fran Frazier from Black Girl Rising. This was an extremely successful event and a strong start for the Speaker Series that will continue in the following League year.

Quick Impacts

During the earlier stages of COVID-19 as restrictions on in-person events continued in Columbus, Quick Impact events were limited. However, the Community Impact Council was able to think creatively and came up with several opportunities for members to volunteer in the community safely. Quick Impacts are fully or partially funded projects and/or volunteer assistance given to selected Community Partners to make a positive and lasting impact in the lives of individuals in our community. Some of these Quick Impact events included helping to sort prom dresses for Fairy Goodmothers, putting together care packages for the youth at Huckleberry House, sorting donations and organizing the youth drop-in center at Kaleidoscope, and preparing blankets for My Very Own Blanket. Quick Impact events give members the chance to learn more about the Central Ohio community and provide direct assistance to organizations serving those most in need.

Kelton House Museum & Garden

The Kelton House Museum & Garden (KH) revamped certain programs like the Girl Scout: HER Story and Underground Railroad to adapt to the new way of operating and relevancy of today's age, explored and executed new programs such as "A Literary Christmas", reinvented events that were postponed like the Second Sunday Series and Fernando's Funeral, and experienced many new visitors from all over. The KH is proud to share as of June 1, 2022, they had 1561 museum guests, 2066 participants in educational programs, and 2284 attendees at events and meetings. Additionally, the KH received more than \$80,000 in grants and donations throughout the League year.

Juneteenth Celebration

A Juneteenth event, Celebrating Freedom, was held at the Kelton House Museum and Garden on June 19, 2022. Over 100 people attended this thoughtful and joyous event. Julialynne Walker, urban agriculture leader, was the featured speaker and a joyous performance by the Columbus State Vocal Ensemble under the direction of Dr. Emma Easton was part of this joyous event. Sarah Richardt, Kelton House Executive Director, began the event by speaking about the story of freedom seeker Rosetta Armistead. 5 Star Planning donated food for the event which

included traditional fare enjoyed at Juneteenth events. The Diversity, Inclusion, Equity and Belonging and the Kelton House Council committees assisted in the preparations of the day. This is the second annual Juneteenth event held at the Kelton House.

Adopt-a-Backpack for Children

Since 1999, the Junior League of Columbus has worked to meet the needs of economically challenged children and families by providing a total of over 65,000 school supply-filled backpacks through the Adopt-a-Backpack for Children (ABC) Project. This League year we raised \$17,350 for the Project through the American Electric Power Foundation Grant and other restricted donations. With these funds we were able to distribute 1,006 supply filled backpacks for kids in Central Ohio.

Friends' Night Out

The Junior League of Columbus' (JLC) Leadership team hosted a "Friends' Night Out" fundraiser on May 5, 2022, at Seventh Son Brewing. This fun event featured a cookie decorating workshop led by drag queen, Plenty O'Smiles, who owns Plenty O'Cookies. The fun evening allowed for two workshops; however guests were able to come early or stay late to socialize and enjoy the beverages at Seventh Son Brewing. For every drink that sold, Seventh Son Brewing donated \$1 back to JLC. We welcomed over 60 guests and raised \$1,390 to support the JLC's three community projects.

A Breakfast with Characters

We were thrilled to hold the 6th Annual A Breakfast with Characters fundraiser on March 12, 2022 at Whetstone Park of Roses Shelter House. This year we welcomed nearly 200 guests and raised over \$4,400 to support Bridging the G.A.P. (Guide.Advocate.Provide) Project. We hosted two opportunities for guests to enjoy fun breakfast food by partners like IHOP and Bob Evans and sweet treats by Sugar Rush Bakery, crafts, entertainment by 3M Media, and, of course, children of all ages met and mingled with their favorite characters brought to us by Amy's Princess Parties and Adam's Mascots. Both sessions also included a silent auction showcasing items from in-demand local businesses.

Kelton House Garden Party and Gala

The 2022 Kelton House Garden Party and Gala raised just over \$9,700 for continuing the Kelton House's mission of providing historical education and preserving decorative arts in Central Ohio. The two day event opportunity allowed guests to enjoy beautiful evenings in the garden and museum. The Bubbles, Bourbons and Brews theme was enhanced by 3M Media playing catchy tunes and The Flowerman centerpieces filled the air with fresh floral scents. Guests enjoyed bites from local establishments like Cameron Mitchell's Hudson 29, Smith and Wollensky, 5 Star Planning and sweets from Sadie Baby Sweets.
